# New Jersey Veterans Diversion Program (VDP)

NJ Criminal Code 2C:43-23 to 2C:43-31 (effective 12/1/2017)

# VDP diverts eligible vets and servicemembers to treatment vs. traditional criminal justice process

- Non-violent 3<sup>rd</sup> and 4<sup>th</sup> degree crimes and DP/PDP offenses
- Dishonorable Discharge not eligible
- Diversion for 6 to 24 months/Superior & Municipal Courts
- No limit to enrollment based on prior diversionary programs
- Monthly court appearances with VDP team and judge
- Features: Accountability, Treatment, Community Support, Benefit Counselling & Mentoring
- A "prosecutor's program" with essential partner buy-in (the VA, providers, Public Defenders, private bar, vet organizations)

### Statistics

- CPM 100% success rate; 5 graduates; 6 current participants
- ATL 85% success rate; 11 graduates; 20 current participants; 2 terms
- ► 5 cases in CPM and 14 cases in ATL not admitted/not qualified
- Over 50 court sessions in two counties since December 2017
- VA key provider/referral for most participants; JFS & other providers
- Cases involve narcotics, thefts, burglary, MV offenses, some DV

VDP involves intensive supervision and treatment monitoring to ensure success of the veteran culminating in the dismissal of the charges and return to society offense free.

- Guide vets to engage and participate in treatment and services
- Expand mentorship relationships
- Encourage graduates to "pay forward" by mentoring or serving as "alumni" examples
- Leverage relationships with providers, government, service and community organizations
- Explore discharge upgrade opportunities to maximize range of benefits
- Formalize graduation event to recognize accomplishment and reentry to the citizen-servicemember ethos

# Veterans Justice Outreach Program

The purpose of the VJO outreach program is to avoid unnecessary criminalization of mental illness and extended incarceration among Veterans by making sure eligible Veterans at risk for homelessness, substance abuse, and physical health problems have access to VA mental health and substance abuse services when they are needed.

# Role of VJO in Veterans Court

- Intake and Assessment;
- Referring to treatment, treatment plan, monitoring progress, court reports.
- Support/education/re-assessment.
- VBA, Vet Centers, VSO, VA State programs
- Talk about non VA treatment. Equine Therapy for PTSD/MH issues; OPTIONS,
- VMC programs, MAP, HAP, Drexel University, SCI program.
- VA ineligible vets DBH role
